4.12 Risk weights

.....

4.12.8 An Authorised Firm must apply a 0% risk weight to any CR Exposure to the qualifying MDBs set out below:

- (a) The World Bank Group comprised of the International Bank for Reconstruction and Development (IBRD), the Multilateral Investment Guarantee Agency (MIGA), and the International Finance Corporation (IFC);
- (b) The Asian Development Bank (ADB);
- (c) The African Development Bank (AfDB);
- (d) The European Bank for Reconstruction and Development (EBRD);
- (e) The Inter-American Development Bank (IADB);
- (f) The European Investment Bank (EIB);
- (g) The European Investment Fund (EIF);
- (h) The Nordic Investment Bank (NIB);
- (i) The Caribbean Development Bank (CDB);
- (j) The Islamic Development Bank (IDB); and
- (k) The Council of Europe Development Bank (CEDB).

4.12.9 An Authorised Firm must apply a 0% risk weight to any CR Exposure to the Bank for International Settlements, the International Monetary Fund, the European

Central Bank, or the European Commission, or the European Stability Mechanism.

A2.4 Reporting to the DFSA

A2.4.1 In the following Table 1:

- (a) the column headed 'Domestic Firm or Branch' indicates whether the relevant form must be prepared and submitted by a Domestic Firm or Branch;
- (b) the column headed 'Authorised Firm Category' indicates which Category of Authorised Firm must prepare and submit the relevant form;
- (c) the column headed 'Frequency' indicates whether the relevant form must be prepared and submitted on a quarterly or annual basis; and
- (d) the column headed 'Semi-annual consolidated reporting for Financial Groups' indicates which Category of Authorised Firm of a Financial Group must prepare and submit the relevant form on a semi-annual basis.
