### THE DFSA HEREBY GIVES NOTICE THAT:

### RULES MODIFIED

The Rules specified in the left hand column are modified to the extent shown in the right hand column of the table below. Where a significant number of the paragraphs of the Rule remain un-altered the entire Rule may not be reproduced in the table. In such circumstances the un-altered parts of the Rule will be referred to by the relevant identifying paragraph number or letter, as the case may be.

<p>GEN 8.6.1</p>	<p>An Authorised Firm or Authorised Market Institution, as applicable, must in writing require its auditor to:</p> <ul style="list-style-type: none"> <li>(a) conduct an audit of the Authorised Person's accounts in accordance with the requirements of the relevant standards published by the International Auditing and Assurance Standards Board (IAASB) <u>or the generally accepted auditing standards ("UK GAAS") issued by the UK Auditing Practices Board,</u> in respect of its financial business;</li> <li>(b) produce a report on the audited accounts which states: <ul style="list-style-type: none"> <li>(i) whether, in the auditor's opinion, the accounts have been properly prepared in accordance with the requirements imposed by this chapter;</li> <li>(ii) in particular, whether the accounts give a true and fair view of the financial position of the Authorised Person for the financial year and of the state of the Authorised Person's affairs at the end of the financial year end; and</li> <li>(iii) any other matter or opinion relating to the requirements of this chapter;</li> </ul> </li> <li>(c) produce an Auditor's Annual Report which states whether: <ul style="list-style-type: none"> <li>(i) the auditor has audited the Authorised Person's annual financial statements in accordance with the IAASB <u>or UK GAAS</u>;</li> <li>(ii) the auditor has carried out any other procedures considered necessary, having regard to the IAASB <u>or UK GAAS</u>;</li> <li>(iii) the auditor has received all necessary information and explanations for the purposes of preparing this report to the DFSA;</li> <li>(iv) .....and so on as per the Rulebook text up to and including (h).</li> </ul> </li> </ul>

## **CONDITIONS**

The provisions in this notice are to be construed in accordance with GEN section 6.2 as if these provisions are provisions of the Rulebook.

Defined terms are identified in this notice by the capitalisation of the initial letter of a word or of each word in a phrase and are defined in the Glossary (GLO). Unless the context otherwise requires, where capitalisation of the initial letter is not used, an expression has its natural meaning.
