GEN 8.6.1	<p>(2)and so on until (3).</p> <p>An Authorised Firm or Authorised Market Institution, as applicable, must in writing require its auditor to:</p> <p>(a) conduct an audit of the Authorised Person's accounts in accordance with the requirements of the relevant standards published by the International Auditing and Assurance Standards Board (IAASB) or <u>International Standards on Auditing (UK and Ireland) issued by the Auditing Practices Board (APB) of the UK in accordance with legal and regulatory requirements under UK Law</u>, in respect of conventional financial business and the Accounting and Auditing Organisation for Islamic Financial Institutions (AAOIFI) in respect of any Islamic Financial Business undertaken;</p> <p>(b)</p> <p>(c) produce an Auditor's Annual Report which states whether:</p> <p>(i) the auditor has audited the Authorised Person's annual financial statements in accordance with the <u>IAASB or International Standards on Auditing (UK and Ireland) issued by APB in accordance with legal and regulatory requirements under UK Law</u>, or AAOIFI in respect of Islamic Financial Business;</p> <p>(ii) the auditor has carried out any other procedures considered necessary, having regard to the <u>IAASB, International Standards on Auditing (UK and Ireland) issued by APB in accordance with legal and regulatory requirements under UK Law</u>, and to AAOIFI auditing standards in respect of Islamic Financial Business;</p> <p>(d)and so on until (h).</p>
